<p>1.1 <i>Opdrag (Acta 2015:144, 1.3.3 en 1.3.4)</i></p> <p>1.1.1 Die Sinode keur die aanbeveling insake die voortsetting van die werksaamhede van die Tussenkerklike Raad – soos hierbo gegee – goed.</p> <p>1.1.2 Die te benoeme Deputate gaan voort om aan die Tussenkerklike Raad deel te neem en alle opdragte soos vervat in die Grondslag van die Tussenkerklike Raad uit te voer.</p> <p>1.1.3 Die te benoeme Deputate gee binne die Tussenkerklike Raad aandag aan die nodige wysigings van die Grondslag van die Tussenkerklike Raad en lê dit aan die volgende Sinode voor vir goedkeuring.</p> <p>1.2 <u>Vir kennisname: Verloop van die gesprek</u></p> <p>1.2.1 Gedurende hierdie termyn het vergaderings van die TKR in 2015, 2016 en 2017 plaasgevind volgens die besluite van 2012 en 2013 om slegs een maal per jaar te vergader.</p> <p>1.2.2 Gedurende die termyn het die NGK die voorsitterskap en skribaats van die TKR beklee.</p> <p>1.2.3 Die gesprek binne die TKR is die afgelope termyn weereens gekenmerk deur indringende besinning aangaande die funksionering en toekoms van die TKR, terwyl die krities-opbouende gesprekke na die bilaterale gesprekke gekanaliseer is.</p> <p>1.2.4 Telkens is weer bevestig dat die drie kerkgemeenskappe – gegewe die geskiedenis van die pad met mekaar – hierdie gesprek nie maar net kan laat los nie.</p>	<p>1.1 <i>Mandate (Acta 2015:144, 1.3.3 and 1.3.4)</i></p> <p>1.1.1 The Synod approves the recommendation regarding the continuation of the activities of the TKR as mentioned above.</p> <p>1.1.2 The to be appointed Deputies continue to participate in the TKR and to execute all mandates as contained in the founding document of the TKR.</p> <p>1.1.3 The to be appointed Deputies give attention within the TKR to the necessary amendments to the founding document of the TKR and tables it before the next Synod for approval.</p> <p>1.2 <u>To be noted: Course of the discussion</u></p> <p>1.2.1 During this term meetings of the TKR took place in 2015, 2016, and 2017 in accordance with the decisions of 2012 and 2013 to only meet once annually.</p> <p>1.2.2 During the term the NGK held the positions of chair and scribe of the TKR.</p> <p>1.2.3 The discussion within the TKR during the past term was once again characterised by incisive reflection on the functioning and future of the TKR, while the critical-edifying discourses were channelled to the bilateral discussions.</p> <p>1.2.4 Time and time again it was again reiterated that the three church communities – given their shared history – cannot simply leave this discussion.</p>
