Voorstel Dat aan die Deputate Emeritaatsversorging opgedra word om:</p> <p>1.1 die probleem te ondersoek van dienende predikante van kerke voorheen van Sinode Middellande en Klassis Capricorn, wat nie voldoende versorging uit die GKSA Predikante Pensioenfonds of die Thusofonds sal ontvang nie.</p> <p>1.2 Om toepaslike oplossings voor te stel en waar moontlik te implementeer ter voorsiening van ondersteuning na emeritering.</p> <p>1.3 Om die volgende Algemene Sinode te adviseer van stappe wat hulle goedkeuring verg.</p> <p>2. Motivering Daar is 29 predikante vanuit die voormalige Sinodes Middellande en Klassis Capricorn wat steeds dien in kerke en eersdaags emeriteringsouderdom nader, maar wat nie ingesluit is in enige voorsiening deur die Predikante Pensioenfonds nie en ook nie kwalifiseer as begunstigdes van die Thusofonds nie.</p> <p>Wanneer hierdie predikante emeriteer, sal hulle versorging 'n onhaalbare las plaas op die kerke waar hulle dien en die onderskeie Klassisse. Alhoewel die Klassis KwaZulu-Natal begin het met ini-</p>	<p>1. Proposal That the Deputies Emeritaatsversorging be assigned to:</p> <p>1.1 to investigate the problem of serving ministers of churches, previously Synod Midlands and Classis Capricorn, that do not receive adequate provision from the GKSA Pension fund or the Thuso Fund.</p> <p>1.2 To recommend and already implement where possible appropriate measures for the provision of their support after retirement.</p> <p>1.3 To advise the next General Synod on measures that need their approval.</p> <p>2. Motivation There are 29 ministers from the previous Synods Midlands and Classis Capricorn who is still serving in churches, and is nearing retirement age while not included in the GKSA Ministers' Pension Fund and they do not qualify for support from the Thuso Fund either.</p> <p>When these ministers retire, their support would place a burden on their churches and respective Classes which would be too large to cope with. Even though the Classis KwaZulu-Natal has started with</p>

Matters that the Synod take note of</p> <p>1.1 The motivation in the Point of description clearly describes the extreme need.</p> <p>1.2 All ministers after 2009 are obligated to be part of the GKSA pension fund.</p> <p>Decision: Points 1.1 and 1.2 noted.</p> <p>2. Matters that the Synod decide on</p> <p>2.1 Effect is given to the Point of description, after pt 1.1 is amended as follows: "to investigate the problem of serving ministers of churches, previously Synod Midlands and Classis Capricorn, that do not receive adequate provision from the GKSA pension fund or the Thuso Fund".</p> <p>2.2 The Deputies Emeritaatsversorging receives the mandate to discuss pt 1.2 with all churches in Classes where the minister does not belong to the Pension Fund.</p> <p>Decision: Points 2.1 and 2.2 approved (amendments already added – Deputies Acta).</p>
