Sake waarvan die Sinode kennis neem</p> <p>2.1 Finansiële bestuur word gedoen volgens 'n goedgekeurde begroting in samewerking met br HJD Coetsee van die Administratiewe Buro.</p> <p>2.2 In die lig daarvan dat die Deputate skuld het, is verskeie stappe geneem om grootskaalse finansiële besparings te maak. Mandate</p> <p>1.1 Acta 2015:262, 2.2.3: The financial management is to continue, as reported.</p> <p>Decision: Noted.</p> <p>2. Matters that the Synod take note of</p> <p>2.1 The finances were managed according to the approved budget, in cooperation with br HJD Coetsee of the Administrative Bureau.</p> <p>2.2 Given the debt the Deputies incurred, a variety of significant cost-saving measures were implemented. A few examples are as follows:</p> <p>2.2.1 The Deputies only held one meeting per year and saved as much as possible on accommodation and travelling expenses.</p> <p>2.2.2 The Deputies started selling furniture and stock no longer in use for application on Youth Care.</p> <p>2.2.3 General savings were made, such as moving to a new Internet service provider.</p> <p>2.3 The Deputies channelled a large amount from the positive Youth Care account to the overdrawn Gee-jaar and Kruispad accounts in order to eventually repay these accounts.</p> <p>2.4 The Deputies wish to express their thanks to the churches for the collection taken up for Youth Care.</p> <p>2.5 The Deputies are proud to report how the debt of both the Gee-jaar and Kruispad accounts have been decreased</p>
