Opdrag Acta 2015:517, 6.4.5. 6.4.5 Om in samewerking met die SBTB en in die lig van nuwe navorsing wat aan die lig mag kom, verdere verdieping van die kerkgroei-bediening te ondersoek, volgende vlakke van implementering voor te stel en die Sinode daarvoor te adviseer”.</p> <p>Besluit: Kennis geneem.</p> <p>2. Sake waarvan die Sinode kennis neem</p> <p>2.1 Uit die werk en ander Rapporte van Deputate Kerkgroei-bediening blyk dit dat, alhoewel baie werk gedoen is en hulp aan die kerke aangebied word, kerke se deelname relatief traag is gesien die nood waarin baie kerke verkeer.</p> <p>Die Sustentatie Deputate het ‘n bepaalde Reglement waarvolgens hulle aansoeke oorweeg. Deel hiervan is dat kerke eers moet aandui watter bedieningsplan hulle in plek het om hul bedienings om te draai en groei te bewerk. Na oorleg met van die Sustentatie Deputate blyk dit egter dat daardie planne en die opvolg daarvan dikwels nie effektief is of effektief opgevolg word deur die Kerkrade nie. Die Sinode het reeds grondige studie gedoen oor wat die beginsels van kerkgroei sou wees, wat die problematiese en selfs sondige elemente in ons kerklike praktyke behels wat roep om bekering en hoe, by wyse van o.a.</p>	<p>1. Mandate Acta 2015:517, 6.4.5. “6.4.5 Focusing on new insights and possibilities as the work of the Church Growth deputies is implemented. Explore the further deepening of the church growth ministry, suggest the next levels of implementation and advise the Synod accordingly in cooperation with the CMTG and in reference to new research that may come to light”.</p> <p>Decision: Noted.</p> <p>2. Matters that the Synod take note of</p> <p>2.1 From the work done by the Deputies Church Growth Ministry, it appears that, although much work has been done and assistance offered to churches, participation by the churches are relatively slow considering the need of many churches.</p> <p>The Sustentation Deputies has specific Rules according to which they consider applications for funds. Part of this is that churches must first indicate the ministry plan they have in place to turn their ministry around and grow. However, after consultation with the Sustentation Deputies, it appears that those plans and their follow-up are often not effective or are not effectively followed by the Church Councils. The Synod has already done a thorough study of what the principles of church growth would be, which involve the problematic and even sinful elements in our church practices calling for repentance and how, through, among</p>

Recommendations</p> <p>3.1 That the Church Growth Deputies, in collaboration with the involved Classes, develop a mechanism for ensuring that churches who receive sustenance from the churches also make use of the services of the OBTB (Expando).</p> <p>Decision: Approved (amendment already added – Deputies Acta).</p> <p>3.2 That this mechanism would include that the OBTB (Expando) would give advice to the Sustentation Deputies by way of progress reports, for their consideration of Sustentation applications.</p> <p>Decision: Approved.</p>
