Acta 2015:526, 2.3.1: “2.3.1.1 ‘n Sentrum vir Bedienings-toerusting en Begeleiding (SBTB) word onder toesig van die Kuratore gevestig. 2.3.1.2 ‘n Persoon word deur die Kuratore aangewys om as koördineerder (Direkteur) van die sentrum op te tree. 2.3.1.3 Die te benoemde Deputate Kerkgroei Bediening en ander rolspelers kan in die vestiging en funksionering van die sentrum betrek word”.</p> <p><b>Besluit: Kennis geneem.</b></p> <p><b>2. In oorleg met kerkregtelik advies is daarna eerder gepraat van die <i>Ondersteuningsdiens vir Bedieningstoerusting en Begeleiding</i> (OBTB).</p>	<p><b>1. Mandate</b> Two assignments are handled in this Report because of their relation.</p> <p>Acta 2015:516, 6.1.4: “To investigate, plan and implement the process of establishing the SBTB in cooperation with the Curators” (see Report Deputies Turn-around Strategy 26.2).</p> <p>Acta 2015:526, 2.3.1: “2.3.1.1 A Centre for Ministry Training and Guidance (CMTG) is established under the supervision of the Curators. 2.3.1.2 A person is appointed by the Curators to act as co-ordinator (Director) of the centre. 2.3.1.3 The nominated Deputies Church Growth Ministry and other role players can be involved in the establishment and functioning of the centre”.</p> <p><b>Decision: Noted.</b></p> <p><b>2. Matters that the Synod take note of</b></p> <p>2.1 <i>Name</i> The initial term used in the Report of the Turnaround Deputies 2012 and the following mandates of Synod 2015: Centre for Ministry Training and Guidance (CMTG) appeared to be problematic with regards to our church polity. After consultation, the following name was subsequently preferred: Support service for Ministry Training and Coaching (SMTC).</p>

This agreement is set out in Addendum A to this Report. Note that in the Addendum the term CMTC is still used. This must read Expando.</p>

Die stand van fondse ontvang ten tye van die Rapport (Junie 2017) word weer-gegee in Addendum C.</p>	<p>2.3 <i>Funding</i> After consultation with the Administrative Bureau and the Curators, it became clear that the Church Growth Deputies would have to provide funds for the establishment and functioning of Expando. There were voluntary collections requested by the Admin Bureau from the churches. After spending a lot of time, investigating and following up on various unsuccessful sustainable funding options, it was decided to approach donors to help with the initial costs of setting up Expando while working on a long-term capital fund that would yield interest to eventually cover the running costs. Thanks to the Lord, funds were obtained to cover the necessary expenses for the start-up phase.</p> <p>The management of all funds is managed by the Admin Bureau and a Management Agreement that also serves as a constitution was prepared for the Capital Fund (Attached as Addendum B). The status of funds received at the time of the report (June 2017) is reproduced in Addendum C.</p>

**1. Agtergrond**

Sinode 2015 het opdrag aan die Kerkgroeideputate gegee om onder toesig van die Kuratore en in samewerking met die TSP en Bestuur van die Admin Buro, die oprig van 'n sentrum vir bedieningstoerusting en begeleiding (SBTB) te ondersoek en te vestig. Die opdragte tov die funksionering aan die sentrum is reeds deur die Sinode bepaal.

In uitvoering van hierdie opdrag het die Kerkgroeideputate 'n vergadering van verteenwoordigers van die Kerkgroeideputate, die Kuratore en die TSP Senaat byeengeroep.

In die lig van die feit dat die Sinodebesluit ten opsigte van die voorgestelde SBTB die indruk kan wek dat 'n *sentrum* naas die TSP geskep word wat eintlik die werk van die beroepe professore doen, asook in die lig van KO, artt 2 en 18 is die benaming verander na Ondersteuningsdiens vir bedieningstoerusting en begeleiding (OBTB). Onder andere is die rol van die Ondersteuningsdiens ten opsigte van die TSP om die professore te ondersteun en tot diens te wees in die uitvoering van hulle opdrag tot verdere bedieningstoerusting en begeleiding van kerke. Hierdie behoefte van die kerkverband is al deur verskeie Sinodes verwoord.

Die wyse waarop sodanige Ondersteuningsdiens binne die GKSA se strukture en Kerkorde tot stand sou kon kom asook aspekte rakende die finansiering en finansiële bestuur van die ondersteuningsdiens is deur verteen-

8.2.3 Final Report from the Deputies Church Growth to the Curators: Request for the establishment of the GKSA support service for ministry training and coaching (SMTC). Request for the establishment of the GKSA support service for ministry training and coaching (SMTC)

**1. Background**

Synod 2015 has tasked the Church Growth Deputies (CGD) with establishing a centre for ministry training and coaching (CMTC) together with Curators, the TSP and the management of the Administrative Bureau. The mandate regarding the task of the centre has already been determined by Synod.

In fulfilling this task the CGD had a meeting with representatives from the CGD, of the curators and the TSP Senate.

In view of the fact that the Synod decision in respect of the proposed CMTC may give the impression that a *centre* is created next to the TSP which actually does the work of the called professors, and in the light of CO, arts 2 and 18, the name was changed to Support Service for Ministry Training and Coaching (SMTC). Among other things, the role of the SMTC with regard to the TSP is to support the professors and to assist them in carrying out their assignment of ministry training and guidance of churches. This need of the churches has already been expressed by various Synods.

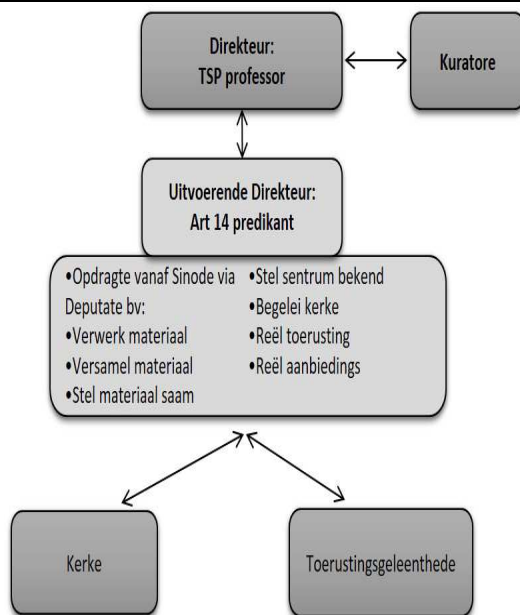
This meeting discussed the way that the SMTC could be established within the framework of GKSA structures and Church Order. The funding and financial management was also discussed. This document contains the result of that

## 2. Plek van die OBTB binne die GKSA

### 2.1 Organogram

### 2.2 Toeligting van organogram

#### 2.2.1 Direkteur

Die OBTB *direkteur* is 'n beroepe professor wat sitting het op die TSP Senaat. Hy gee gevolglik die nodige deurvoer aan die *uitvoerende direkteur* van die Ondersteuningsdiens vanaf die Senaat en lewer ook die nodige *terugvoer*. Hy is verder ook deel van die Sinode se Kerkgroei-deputate vanwaar die oorspronklike opdrag kom en waarheen gerapporteer moet word aan die kerke.

#### 2.2.2 Uitvoerende Direkteur

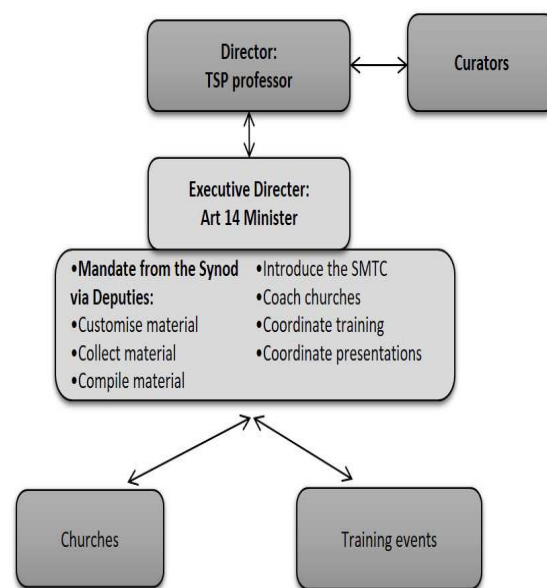
Die *uitvoerende direkteur* is 'n predikant wat op versoek van die Kuratore aan 'n spesifieke Kerkraad, onder KO, art 14 toestemming ontvang om sy diens vir 'n tyd lank te onderbreek,

## 2. Place of the SMTC within the GKSA structures

### 2.1 Diagram

The following diagram shows how the centre can be established in an orderly manner within the GKSA and its relation to other role-players.



### 2.2 Explanation of diagram

#### 2.2.1 Director

The *director* is a TSP professor and member of the TSP Senate and Curators. He gives feedback to these entities regarding the centre and also gives input to the executive director from the TSP Senate and Curators. He also serves on the Church Growth Deputies of the Synod where the original task of the centre was determined and reports back to the churches at Synod.

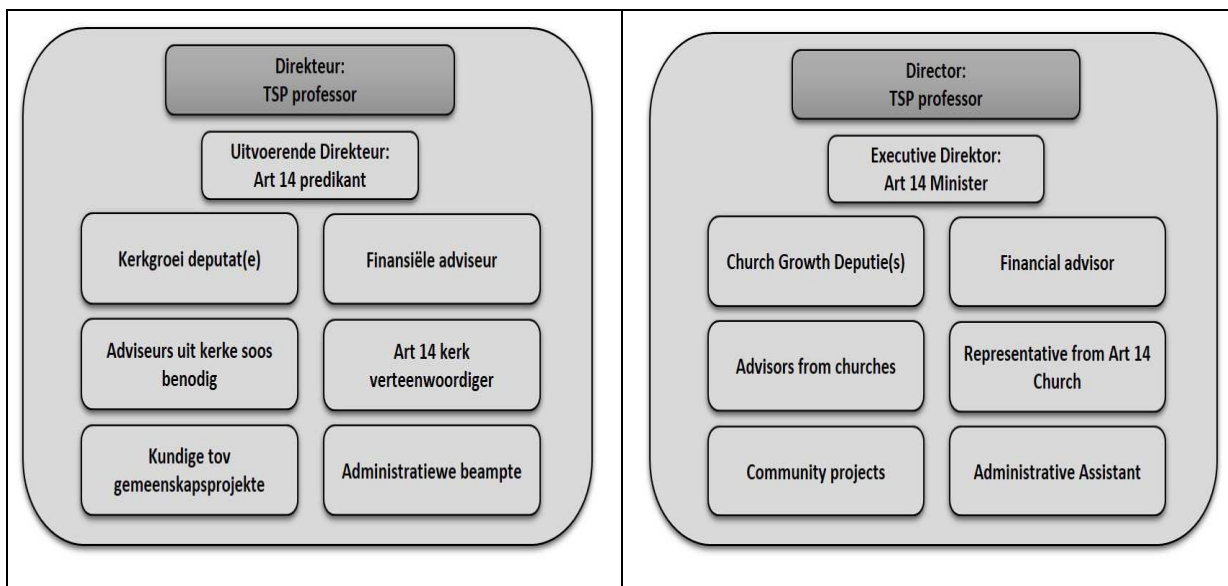
#### 2.2.2 Executive Director

The executive director is a minister from a local church requested by the Curators according to CO, art 14 to interrupt his ministry in that church for a time to serve as executive director of

Hierdie bestuur bestaan uit die direkteur (TSP professor), uitvoerende direkteur (art 14 predikant), administratiewe beampete, finansiële adviseur, verteenwoordiger van die Kerkgroei-deputate, adviseurs van verskillende belangegroepe van die kerke, 'n kundige op die gebied van gemeenskapsprojekte en 'n verteenwoordiger van die plaaslike kerk van die art 14 predikant.

### 3. Finansiering en finansiële bestuur

Die besluit van die Sinode lui dat die Kerkgroei-deputate in samewerking met die Kuratore en die bestuur van die Admin Buro 'n finansieringsplan ondersoek en indien moontlik in werking stel. Kontak is deur die Kerkgroei-deputate met donateurs uit die kerke gemaak wat bereid is om te help om die sentrum te befonds. Finale ooreenkomste hang af van die finalisering van die ondersteuningsdiens se oprigting en bestuur. Kortliks behels die plan dat aanvanklike bedryfskapitaal deur donasies vir die eerste 3-5 jaar verkry word. In hierdie tyd word langer termyn planne in werking gestel om 'n kapitaalfonds op te bou en moontlik kollekte van die kerke in te faseer om volhoubare finansiering te bewerk. Die Admin Buro administreer hierdie fondse.

Sodra finaliteit van alle partye verkry is oor die oprigting van die OBTB soos voorgestel in hierdie dokument is aanvanklike fondse reeds beskikbaar

This team will consist of the director (TSP professor), executive director (art 14 minister), administrative officer, financial advisor, member of Church Growth Deputies, advisors from churches, people experienced with community projects and a representative from the art 14 Church.

### 3. Funding and financial management

The decision of Synod is that the CGD together with the Curators and the management of the Admin Bureau should research a plan for funding the centre and, if possible, execute it.

The CGD has made contact with possible sponsors but final agreements can only be made when the final decisions has been made by the TSP Senate, the Curators and the CGD. Shortly the plan involves two strategies. First sourcing the funds for initial operational expenses and gaining the services of a fundraiser. Secondly to establish and build an investment fund that would be able to support the work of the centre through interest earned. The Admin Buro will administrate these funds.

As soon as a final agreement has been reached regarding the establishment of the SMTC as proposed in this document, funds are already available to appoint a
